Client Agreement and Release of Liability: I hereby release A Diamond in the Ruff, Inc. its agents, officers, employees, customers and potential customers of A Diamond in the Ruff from any and all liabilities, financial, and otherwise, for injuries to myself, my family or guests, my dog, or any other property of mine, which arise in any way from services and/or products provided by or as a consequence of my associations with A Diamond in the Ruff, Inc.

I agree to assume all liabilities and responsibilities, financial and otherwise, for the behavior and health of my dog(s). In consideration of the services rendered by A Diamond in the Ruff, Inc, I waive any and all claims, actions, or demands of any nature, foreseen or unforeseen, that I may have against A Diamond in the Ruff relating to the care, control, health, and/or safety of my dog arising during pick up, drop off or play time.

I hereby waive and release A Diamond in the Ruff, Inc., it's employees, owners and agents from any and all liability of any nature, for injury or damage which I or my dog may suffer, including, but not limited to any injury or damage resulting from the action of any dog(s); and I expressly assume the risk of any such damage or injury while on the premises of A Diamond in the Ruff or in the surrounding area. In consideration of and as a inducement to the acceptance of my application for doggie daycare participation, I/we hereby agree to indemnify and hold harmless A Diamond in the Ruff, Inc., its employees, owners and agents from any and all claims, or claims by any member of my family or any other person accompanying my dog to A Diamond in the Ruff premises or in the surrounding area as a result of any action by any dog, including my own.

I authorize A Diamond in the Ruff, Inc. to ado whatever they deem necessary for the safety, health, and well-being of my dog while under their care, including seeking veterinary treatment of my dog.

I understand that A Diamond in the Ruff, Inc. has the right to refuse service to me and/or my dog at any time for any reason. I understand that if my dog has a history of or repeatedly demonstrates aggression or biting of humans or animals, A Diamond in the Ruff reserves the right to refuse service.

I hereby declare I am the legal owner of my dog; that my dog has not been exposed to any infectious disease within the past 30 days and has been inoculated as indicated by the records presented by my veterinarian.

Payment Requirements: I understand that the hours of operation for day care are 6:30AM – 6:00PM Monday thru Friday. A \$1/minute late fee applies after 6:00PM until 6:30PM to be paid in cash upon arrival. If I have not picked up my dog by 6:30PM there is an added late fee of \$25 per 15 minute intervals. Should this take place I authorize in advance A Diamond in the Ruff to automatically charge my credit card in the total amount not to exceed \$100.

I authorize A Diamond in the Ruff, Inc. to charge my credit card for any outstanding balance on my account. I understand I will be charged a \$30 fee for each returned check.
